# RESOLUTION IN SUPPORT OF PARD REQUEST

WHEREAS, At present, PARD has only 20 park rangers, who must cover 300 parks; and

WHEREAS, This staffing number is woefully inadequate, as can be seen every day in Zilker Park and other parks throughout the city; and

WHEREAS, From March 15 to April 15, park rangers handled more than 1,700 interactions with the public regarding laws, safety, service, and education; and

WHEREAS, Zilker Park was far and away the most frequent location for these interactions, making up more than 1,100 of all interactions; now, therefore, be it

RESOLVED, That ZNA Excom supports PARD's request for more park rangers, extra security, training programs for its staff, and extra security at Barton Springs Pool.

## RESOLUTION OPPOSING ENCAMPMENTS IN PARKS

WHEREAS, Encampments in city parks are not a solution to the homeless problem, as parks have inadequate services for people experiencing homelessness; and

WHEREAS, Not only is PARD ill-equipped to handle any aspect of our homeless problem, the encampments are often harmful to the environment; and

WHEREAS, PARD is already under-resourced for the job of park management and is not qualified to manage homeless encampments; now, therefore, be it

RESOLVED, That ZNA Excom opposes any efforts to set up homeless encampments in any park and opposes efforts to have PARD play a lead role in homeless efforts in Austin; and, be it further

RESOLVED, That ZNA Excom supports efforts to house our homeless neighbors in shelters with adequate facilities for bathing, showering, cooking, and sleeping and recommends that residents of these shelters be supported with "wraparound services" for addiction recovery, job training, and other social needs.

RESOLUTION ASKING ANC TO JOIN THE SUMMIT TO END HOMELESSNESS WHEREAS, The ZNA Excom recognizes that homelessness affects our neighborhood and every other neighborhood in Austin, and

WHEREAS, The ZNA Excom understands that there is currently no neighborhood representation on the Summit for Ending Homelessness; now, therefore, be it

RESOLVED, That ZNA requests that the Austin Neighborhood Council consider joining the Summit for Ending Homelessness by reaching out to Lynn Meredith, who is chair of the summit.
