Drama Continues for the Zilker Park Vision Plan

There is something shady going on with the Zilker Park Vision Plan – and it's not the trees! What once seemed like a "fun" chance to participate in a planning process for the long-term future of our beloved Zilker Park has turned into something far different.

Concerns about the Vision Plan abound. Close Barton Springs Road down to one lane? Spend \$60 million on parking garages, including one underground garage threatening critical watershed features? Lack of equity? Lack of public safety? Lack of climate mitigation? Still no rewilding? These problems with the draft plan have all been expressed by your neighborhood Parks volunteers, who have joined with other neighborhood groups and environmental organizations to form www.Rewildzilker.org. Please visit this website to get all the latest news.

But perhaps the biggest concern is the hidden role of ACL/C3/ LiveNation/Ticketmaster, which, until last Friday, was completely cloaked. The city's consultant adamantly told the Austin Chronicle that ACL/ Ticketmaster "was not at the table." But, one week ago, the City suddenly published a list of five meetings held with ACL/Ticketmaster with just dates. No transcripts, video, or notes. When details were requested by the Parks Board, they were told to file a formal Public Information Request. All other meetings were posted with video.

Our worst fears were realized. ACL/Ticketmaster has the right to participate in the plan. But their needs should be public and taken into account alongside all other groups. And commercial interests should definitely NOT be put above the needs of everyday park people. The issue with the Zilker Park Vision Plan has turned into a battle between those who use the park to swim, play, commune with nature – and those who seek to make a buck.

At the Parks Board meeting on Monday, February 27th, upwards of 100 speakers told the Board in no uncertain terms that they wouldn't stand for this kind of shady business. The Parks Board responded with a vote of 6-2 to remove the mysterious "umbrella management nonprofit" that would have likely reduced accountability and transparency for Zilker Park and put its fate in the hands of unknown donors and their commercialized interests.

517 South Lamar Development Updates "The Bike Shop PUD"

The current location of the Trek Bike Shop, St. David's Urgent Care and ATXFOODCO is under contract to be bought by a developer. The developer will be using a process called a Planned Unit Development (a "PUD") used by large developers all around Austin to get direct access to the City Council to request rezoning of specific properties (spot zoning). A PUD allows big developers to write their own zoning rules, with zero regard for the existing Land Development Code.

ZNA is concerned about this development because the developer for the Bike Shop PUD is requesting a minimum of 102 feet in height, which is massively higher than current buildings on Lamar. This building will tower over our neighborhood, even with the natural bluff behind it. It will overburden the infrastructure in our area, and represents nothing more than special-favor paybacks by the City to developers. The developer is also requesting special waivers and exceptions for increased density, floodplain, water quality, massing and natural buffer zones. Further, the developer professes to provide superior affordable housing, while actually providing much less than would be required if they went through the currently approved Land Development Code. The Bike Shop PUD would set a precedent for the rest of Lamar. In other words, it's a golden ticket for big developers. What can you do? Sign the petition at 787 coalition.com and email your City Council member to request that they vote NO to the Bike Shop PUD. With new council members in Districts 5 & 9, now is the time to have your voice heard.




